Resolutions 1-6 are proposed as ordinary resolutions. This means that for the ordinary resolutions to be passed, more than half of the votes cast must be in favour of the resolutions. Resolutions 7 and 8 are proposed as special resolutions. This means that for the resolutions to be passed, at least three-quarters of the votes cast must be in favour of the resolutions.

Resolution 1 (annual report and accounts)

The directors of the Company must present to the meeting the audited annual accounts and the directors' and auditors' report for the financial period ended 31 December 2022.

Resolution 2 (remuneration report)

The Company's shareholders will be asked to approve the remuneration report at the Annual General Meeting.

Resolutions 3 and 4 (reappointment and remuneration of auditors)

The Company must appoint auditors at each general meeting at which accounts are presented to shareholders to hold office until the conclusion of the next such meeting. Following exceptional circumstances, Resolution 3 seeks shareholder approval to reappoint HGC Chartered Accountants of 310 Friern Barnet Lane, London, N20 0LD as the Company's auditors. In accordance with normal practice, Resolution 4 seeks authority for the Company's directors to fix their remuneration.

Resolution 5 (retirement and re-appointment of director)

Jeffrey Reingold is standing for reappointment as a director, in accordance with Article 77.1.1 of the articles of association of the Company.

Resolution 6 (authority to allot)

Resolution 6 would give the directors the authority to allot shares in the Company and grant rights to subscribe for or convert any security into shares in the Company up to an aggregate nominal value of £3,500,000.

This authority is being sought to enable the directors to provide the directors with a general authority of shares to be used at their discretion and to enable the Company to grow and expand as envisaged by the directors. This special resolution gives the directors authority, for the period ending on 30 June 2024, to allot shares of the Company, or sell treasury shares, for cash up to an aggregate nominal value of £3,500,000 in each case as if the pre-emption rights in company law did not apply. This disapplication of statutory pre-emption rights relates to the authority to allot as proposed under resolution 6.

Resolution 8 (authority for market purchases of own shares)

Resolution 8 grants the Company authority to make limited market purchases of the Company's ordinary shares. The authority is limited to a maximum aggregate number of 192,951,558 ordinary shares and sets out the minimum and maximum prices that can be paid, exclusive of expenses.
